

## CTE Transitions Credit by Exam DAC Update March 2023

### New Agreement

A New Noncredit to Credit Agreement has been established effective this spring 2023 semester: SDCCE's HMDV 581 to City College's CHIL 160; effective Spring 2023 and 2023-24, and 24-25 academic years.

### Agreement Development

Discussions are underway for the following agreements:

- City:
  - CISC 179 – requested by E3Civic; high school course materials being reviewed by faculty member; course already approved for CBE with noncredit.
    - *Most likely, this agreement will not move forward.*
      - *City College faculty have been notified of the concerns and notes from the past DAC meeting regarding this course were shared*
      - *E3Civic has been notified that there are concerns and the request is being explored more closely.*
    - *Waiting on final decision from City College.*
  - INWT and SDCCE's courses – SDCCE and City College met recently to review and discuss existing agreements and explore revised final assessments.
    - *Changes are still in discussion.*
    - *Final confirmation will occur soon and inform renewals effective for fall 2023.*
  - CHIL 291 A-D (City and SDCCE) – course alignment confirmed; lead faculty member working with faculty from all three credit colleges to confirm for CBE approval; will be initiating curricUNET process for CBE approval
    - *No change since February Update*
- Mesa:
  - Child Development and San Diego County Office of Education (SDCOE). Mesa College faculty exploring potential partnership with SDCOE. SDCOE sharing courses for Mesa faculty to review. *College courses TBD.*
  - Revised noncredit Front-End Web Development (FEWD) agreement.
    - *No change since February Update*
    - *Faculty have been working on this update/change for a while; approved final assessments being collected. New agreement will begin Fall 2023. Revised course mapping approved by credit college faculty:*

- New report available:
  - [CBE Re-Enrollment & Pathway Enrollment Report](#) (February 2023)
    - Highlights Include:
      - 31% of CTE Articulation CBE students re-enrolled at San Diego City, Mesa, or Miramar as college students. 1-year re-enrollment rates appear slightly lower than for concurrent and CCAP students.
      - Of the students who re-enroll, 21% enroll in a pathway related to their CTE Articulation Credit-by-Exam. This varies by agreement, with well over half of credit earners in Child Development and Education agreements enrolling in those pathway.
      - Pathway awards are rare, and mostly accounted for by the 8-unit credit certificate for Biotechnology.
