

## CTE Transitions Credit by Exam DAC Update September 2023

### Renewal Updates

The renewal process will begin fall 2023 for all active agreements set to expire in 2024. An initial approval will be solicited via email to discipline faculty. Once confirmed, renewal agreements will be distributed for signature approval via DocuSign.

- There are 30 SDUSD and Out of District agreements that are up for renewal at City, Mesa and Miramar.
- There are 12 SDCCE agreements that are up for renewal at City, Mesa, Miramar.

### Agreement Updates

- Cancelled Agreements
  - SDCCE's INWT 100 was not renewed for fall 2023 due to faculty feedback; faculty continuing to work on alignment and final assessment improvements
- New Agreements for 2023-25
  - CHIL 291 (A-D) has been approved at City, Mesa and Miramar for 2023-25

### Agreement Development

Discussions are underway for the following agreements:

- Mesa College –
  - ARCH 107 –
    - Faculty have confirmed alignment between Mesa College's ARCH 107 course and SDUSD's Architectural Design 1,2 Honors course. Waiting for final assessment confirmation from college faculty.
    - Faculty need to submit course for CBE approval.
  - NUTR 160
    - SDUSD expressed interest in adding an additional high school course to articulate with an existing NUTR 160 agreement Nutrition 1,2
    - Waiting for faculty feedback.
    - College course already approved for CBE and tied to active agreement
  - BIOL 160
    - SDUSD expressed interest in agreement development with their Human Body Systems 1,2 / Honors Human Body Systems 1,2 (currently articulated to MEDA 055; SDUSD seeking alternative college course)
    - Course is not yet approved for CBE
    - Waiting on faculty response

- EXSC 242B
  - Waiting on faculty response
  - DAC approved during December 2022 meeting
  - Course is not yet approved for CBE
- Vet Tech
  - Altus Charter School submitted curriculum for review; meeting planned for fall 2023; no college course selected yet
- Child Development
  - SD County office of Education expressed interest in possible articulation; college faculty exploring; no course(s) selected yet
- Miramar:
  - BIOL 132
    - Course alignment and final assessment confirmed by college faculty
    - Cost of proctoring and access to exam needs to be addressed by Miramar and School site (Mira Mesa) / SDUSD
    - Course needs to be submitted for CBE approval

## Process Revisions Reminders

**SDCCE Credit by Exam Process Updates** – Updates to SDCCE’s internal processes are complete.

- Opt-in model in effect (as of Fall 2022)
- Noncredit courses tied to active agreements identified within the online schedule
- Final assessment grades entered into campus solutions

## Overall Course Grade Eligibility

In Spring 2023, in alignment with the SDUSD/SDCCD Joint Board Goals, the Vice Chancellor for Educational Services and Vice Presidents of Instruction at City, Mesa, and Miramar approved a change to the overall course grade eligibility requirements for CTE Transitions high school to college and noncredit to college articulation credit by exam effective fall 2023.

- **Beginning Fall 2023, the overall course grade eligibility requirement for Articulation Credit by Exam is a C- or higher**
  - This change does not impact any existing formal SDCCD Policy or Administrative Procedure nor does it impact the overall process of CTE Transitions Credit by Exam, agreements, or faculty activities tied to the agreements.
  - Updating the overall course grade requirement to C- or higher brings CTE Transitions Credit by Exam course grade eligibility into alignment with other districtwide course success metrics.
  - This change aligns CTE Transitions course success with our high school partners’ course success measures C- or higher is both the SDCCD course success measure (across all four colleges) and K12’s course success measure).
- **No change to course-to-course alignment** - CTE Transitions Articulation

Credit by Exam will continue to require course-to -course alignment (no change). Alignment will continue to be confirmed by college faculty and confirmed via the signed agreement.

- **No change to End of Course Grade Eligibility** – End of Course (EOC) grade eligibility will remain unchanged. EOC grade eligibility requires the student to receive a B or higher on the college faculty approved final exam/assessment (no change).
- **No change to the grade that is transcribed** – the grade transcribed to the college transcript will remain the end of course (EOC) grade which will remain B or higher (no change).

Grade Eligibility Requirements	Current	Approved for Fall 2023	Notes
Overall course grade	B or higher	C- or higher	This grade does not appear on our college transcripts. Updating the requirement brings us into alignment with districtwide metrics/measures of course success and K12 measures of course success.
End of course grade	B or higher	No change	The end of course grade is the grade that is transcribed (no change)
