

Concurrent Enrollment






Outcomes

- 88% of concurrent enrollments across the credit colleges were successful in 2022-23 (City: 87%, Mesa: 89%, Miramar: 89%).
- Students from the class of 2023 earned on average 6 units through Concurrent enrollment.

CTE Articulation Credit by Exam (CBE)








Outcomes

- 91% of grade-eligible students earned college credit in 2022-23, down slightly from last year but up almost 20% from 2019-20.
- The percent of all enrolled students who met course requirements increased, from 58% in 2021-22 to 62% in 2022-23.
- African American, Latine, and Special Ed students continue to be DI in earning college credit, although gaps shrank in 2022-23.




College and Career Access Pathways (CCAP)

San Diego Mesa College Teacher Education

Education 100 provided new learning material that I otherwise would never see in a classroom.... I used the material to reflect on old tutees I've had. I thought about good things I did without realizing, and I thought of moments (many moments) that I could have done better, or said something different...[so] I took the opportunity to focus my learning on a specific aspect of tutoring: equity...My approach to tutoring has changed because now the phrase "meet the tutee where they are" is more than just words. It's a call to action to be more equitable and fill in the gaps that have been created by systemic issues and prejudices. I, as a tutor, a highschool student, and a person, am on a constant journey of growth. This course focuses heavily on the idea of being kind to yourself. From the MT2C mottos, to the tutoring cycle, to the Learning Apprenticeship Framework, it hammers in the fact that you need to start with yourself. This mindset has helped me become a better learner and a better tutor. I am kinder to myself when I learn, and because I handle my own frustrations when learning in a healthy way, I can help a tutee do the same. This concept is not only important in a learning environment, but in everyday life as well. Becoming more equitable is not an overnight process. There's no switch to flip to suddenly become an equitable tutor. It's something that takes constant awareness and work, but not something that is unachievable...



San Diego Promise | Promise Outcomes Fall 2023

Promise students tend to have higher retention and outperform non-Promise students in terms of course completion and success.

- Yet equity gaps persist for Black and Latine students.
- Survey data show that the unit load requirement and lack of 1-1 support inhibits student success in the program.

In Fall 2023, Black and Latine students in Cohort 8 were disproportionately impacted in course success.

This is similar to outcomes for previous cohorts.

Compared to non-Promise students, Cohort 7 had 28% higher retention from first Fall to first Spring.

 While Promise student retention is higher than those not in Promise, only 68% of Cohort 7 students completed the Promise program, and there is still work to do to improve retention for students within and outside of San Diego Promise.

SB 895 (Roth)/AB 2104 (Soria) would allow a pilot program of 15 community college districts statewide to offer a Bachelor of Science in Nursing degree.

Noncredit Education Reform package is a series of reforms that the San Diego Community College District and others are proposing to expand the capacity of noncredit education to offer adult learners equitable access to education that leads to economic mobility.



AB 247 (Muratsuchi) would place a \$14B facilities bond on the 2024 ballot to support construction and modernization of school facilities at TK-12 public schools and community colleges.

AB 2112 (Muratsuchi) would stabilize funding for expanded learning opportunities at districts.

GOAL 1: San Diego Unified students' level of college and career readiness, as measured by the college/career indicator on the California State Dashboard, will increase from 60.8% in Spring 2023 to 80% by Spring 2027.

2025 Interim Goal: 65% of students in the *Class of 2025* will be college/career ready based on the State Dashboard indicator.

2026 Interim Goal: 70% of students in the *Class of 2026* will be college/career ready based on the State Dashboard indicator.

2027 Interim Goal: 80% of students in the *Class of 2027* will be college/career ready based on the State Dashboard indicator.

OUTPUT 1a: San Diego Unified students will increase their rate of participation in at least two community college courses from 33% in Spring 2023 to 55% by Spring 2027.

2025 Interim Output: 38% of San Diego Unified students will have taken at least two community college courses (i.e., dual enrollment, concurrent enrollment, and CCTE articulation by exam).

2026 Interim Output: 48% of San Diego Unified students will have taken at least two community college courses (i.e., dual enrollment, concurrent enrollment, and CCTE articulation by exam).

2027 Interim Output: 55% of San Diego Unified students will have taken at least two community college courses (i.e., dual enrollment, concurrent enrollment, and CCTE articulation by exam).

OUTPUT 1b: San Diego Unified will increase the participation rate of Latinx student groups in Career and College Access Pathways (CCAP) from 11.2% in 2022-2023 to 15.2% in 2025-2026.

2023-24 Interim Output: 12.2% of San Diego Unified Latinx students will have participated in CCAP.

2024-25 Interim Output: 13.7% of San Diego Unified Latinx students will have participated in CCAP.

2025-26 Interim Output: 15.2% of San Diego Unified Latinx students will have participated in CCAP.

OUTPUT 1c: San Diego Unified will increase the participation rate of African American student groups in Career and College Access Pathways (CCAP) from 13% in 2022-2023 to 17% in 2025-2026.

2023-24 Interim Output: 14% of San Diego Unified African American students will have participated in CCAP.

2024-25 Interim Output: 15.5% of San Diego Unified African American students will have participated in CCAP.

2025-26 Interim Output: 17% of San Diego Unified African American students will have participated in CCAP.

GOAL 2: The percentage of San Diego Unified students who enroll at the San Diego Community College District who receive the San Diego Promise scholarship will increase from 58% in Fall 2022 to 90% in Fall 2025.

Fall 2023 Interim Goal: SDCCD will provide San Diego Promise Scholarships to 60% of San Diego Unified students enrolling at the San Diego Community College District.

Fall 2024 Interim Goal: SDCCD will provide San Diego Promise Scholarships to 75% of San Diego Unified students enrolling at the San Diego Community College District.

Fall 2025 Interim Goal: SDCCD will provide San Diego Promise Scholarships to 90% of San Diego Unified students enrolling at the San Diego Community College District.

OUTPUT 2a. San Diego Unified will increase the number of graduates who have submitted an application to the San Diego Promise Program from 28% in Fall 2023 to 85% by Fall 2025.

2024 Interim Output: 45% of San Diego Unified graduate students will have submitted an application to the San Diego Promise Program.

2025 Interim Output: 65% of San Diego Unified graduate students will have submitted an application to the San Diego Promise Program.
