Meeting Notes

Participation: All four colleges represented

Counts as of 5/1/23

- Student Activations: 5,774
 - City - 1,170
 - Mesa - 1,767
 - Miramar - 1,043
 - Continuing Ed - 752
- Approved Employers - 4,978
- Job Postings - 7,197

- SDCCE shared that they will be hosting summer and fall events to bring up student activation numbers
- Mesa College shared that their executive leadership is requesting weekly reporting on counts.
 - Need to ensure we are all pulling the counts the same way; unfortunately, it seems you can pull them multiple ways and they all show different numbers
 - District CEWD to reach out to Handshake Rep to explore data inconsistencies

Accepting Payments

- Updates from Colleges – local discussions with accounting offices
 - City shared that in the past CCN accepted credit card payments and then sent them a check which they deposited in the career centers fiduciary account via their accounting office
 - City, Mesa, and Miramar shared that they spend a lot of time tracking down missing payments
 - There is a need to reduce the amount of staff time it takes to track down payments
 - Miramar shared that they plan on meeting with their accounting office in the coming months

- SDCCE spoke with their accounting office; currently there does not seem to be local capacity to accept credit card payments
- Mesa shared that while no recent meetings have been held with their accounting office, in the past they have said no to processing credit card payments; planning to hold June meetings; past activities were all processed via check; they are still hunting down past checks from fall events
- Update from District – exploration of centralized model
 - CEWD to work with District Offices to explore what a centralized model might look like
- Stripe versus TouchNet – timing considerations
 - Colleges agreed that a quality set up/resolution is preferred over a fast solution; if it takes longer to set up that is fine (fall 2023 may not be possible)
 - We will continue to prioritize the issue
 - District level conversations needed to engage accounting offices
 - Local conversations still important and key to supporting the process though
 - Meeting participants expressed preference for a local model that they can control directly rather than a centralized model; this may or may not be possible depending on the software selected to manage the payments and the local accounting office's capacity constraints
 - Concerns were expressed regarding touchnet
 - Regardless of which software is selected, IT will need to be involved and performance measures built into contract

- City - new Job Placement Coordinator will take the lead on handshake; position not yet filled
- Mesa – working on expanded handshake communication to students; focusing next emails on the career services offered at Mesa College and targeting grads; during commencement rehearsal and check-in, Mesa will be showcasing handshake on the slides while folks are waiting; recommended other colleges to consider doing the same thing
- Miramar – recent child development and diesel specific career fairs were handled completely through handshake; 40 students registered prior to the events; 80 checked in; boutique fairs will continue to be a focus for Miramar
- SDCCE – working on overall SDCCE website re-design; will be including promotion of handshake
- District – Student uploads will be made each month during the first week of the month; colleges will be notified once uploads are complete
