Data Engagement:

Group discussion was focused on our 2022-23 priority project to increase our understanding and insight into shared customers/students

- Updates were shared:
 - Data Sharing MOU established summer 2022
 - Data exchange for required Perkins reporting refined; schedules set
 - Shared Customer/Student definition refined - focused on Workforce Partnership WIOA Title 1 customers with one or more enrollments at an SDCCD institution
- Presentation: Chris Cruzcosa presented insight into shared customers/students as defined as above specifically within FY22 (July 1, 2021 through June 30, 2022) via a [new dashboard](#) that connects SDCCD data and Workforce Partnership data.
 - Dashboard components:
 - Student Demographics
 - Workforce Partnership Programs/Services Provided
 - Job Placements and Wages
- Notes and Discussion Highlights:
 - Dashboard overall notes: Click on the charts to filter the data
 - Workforce Partnership Services and Programs Notes:
 - Counseling – baseline service everyone gets
 - Supportive Services and Training – these are more high touch, intensive services
 - Support Services: Bus passes to support for paying rent
 - Training: Assistance for covering the cost of certifications to participation in apprenticeship programs

Meeting Highlights

- Job and Wage insight notes: Self reported
 - CTEOS has a similar methodology; explore opportunities to bring this data into the mix
 - WIOA II wage/job reporting – also similar methodology; explore opportunities to bring this data into the mix
 - Kelly to follow-up with Amertah, Marc, and Chris
- Concerns expressed regarding the large loss of adult learners within the community colleges
 - How can we work together to re-engage adult learners? What data could we use to help support these efforts?
- **Action Item: All committee members are encouraged to continue to explore the dashboard shared today, discuss it internally, and provide feedback.**
 - **Are there any specific questions you want to answer that could strongly shape our partnership and/or your programs and services?**
